California FMMO Approved by Producers

The U.S. Department of Agriculture (USDA) recently announced that California dairy producers voted to approve a Federal Milk Marketing Order (FMMO) for the entire State of California.

The new California FMMO will be implemented October 17, 2018, with publication of the *Announcement of Advanced Prices and Pricing Factors*, and affected parties must comply with all provisions beginning November 1, 2018.

The Final Decision on which producers voted is based on the record of a public hearing held September 22 through November 18, 2015 in Clovis, California.

USDA will work over the next few months to educate handlers who will become regulated by the new FMMO.

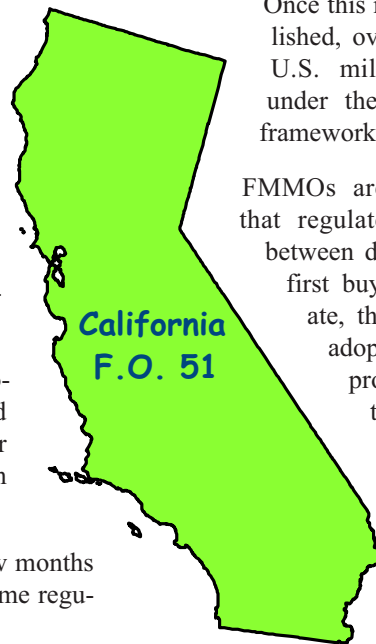
California represents over 18 percent of all U.S. milk production and is currently regulated by a state milk marketing order

administered by California Department of Agriculture (CDFA).

Once this new FMMO is established, over 80 percent of the U.S. milk supply will fall under the FMMO regulatory framework.

FMMOs are legal instruments that regulate the sale of milk between dairy farmers and the first buyer. Where appropriate, the California FMMO adopts the uniform order provisions contained in the ten current FMMOs in the national system. (See the map on Page 2.)

These uniform provisions include, but are not limited to, dairy product classification, end-product price formulas, and the producer-handler definition.

Pool Summary

- In May, producer milk totaled 2.6 billion pounds, down 3.5% from last month on a daily basis and 5.4% below last year. In May, an estimated 963 million pounds of eligible milk was not pooled because of class price relationships.
- Class I utilization totaled 258 million pounds, down 2.0% from April on a daily basis and 8.3% below last year.

In May, Class I usage accounted for 10.0% of producer milk.

- The May Producer Price Differential (PPD) was \$0.07 per cwt.
- The Statistical Uniform Price was \$15.25 per cwt., up \$0.71 from April, but \$0.40 below May 2017.
- Market statistics for May are shown on Pages 3, 4 and 5.

FMMO employees will hold three handler training sessions in July 2018. All trainings will have a large group session

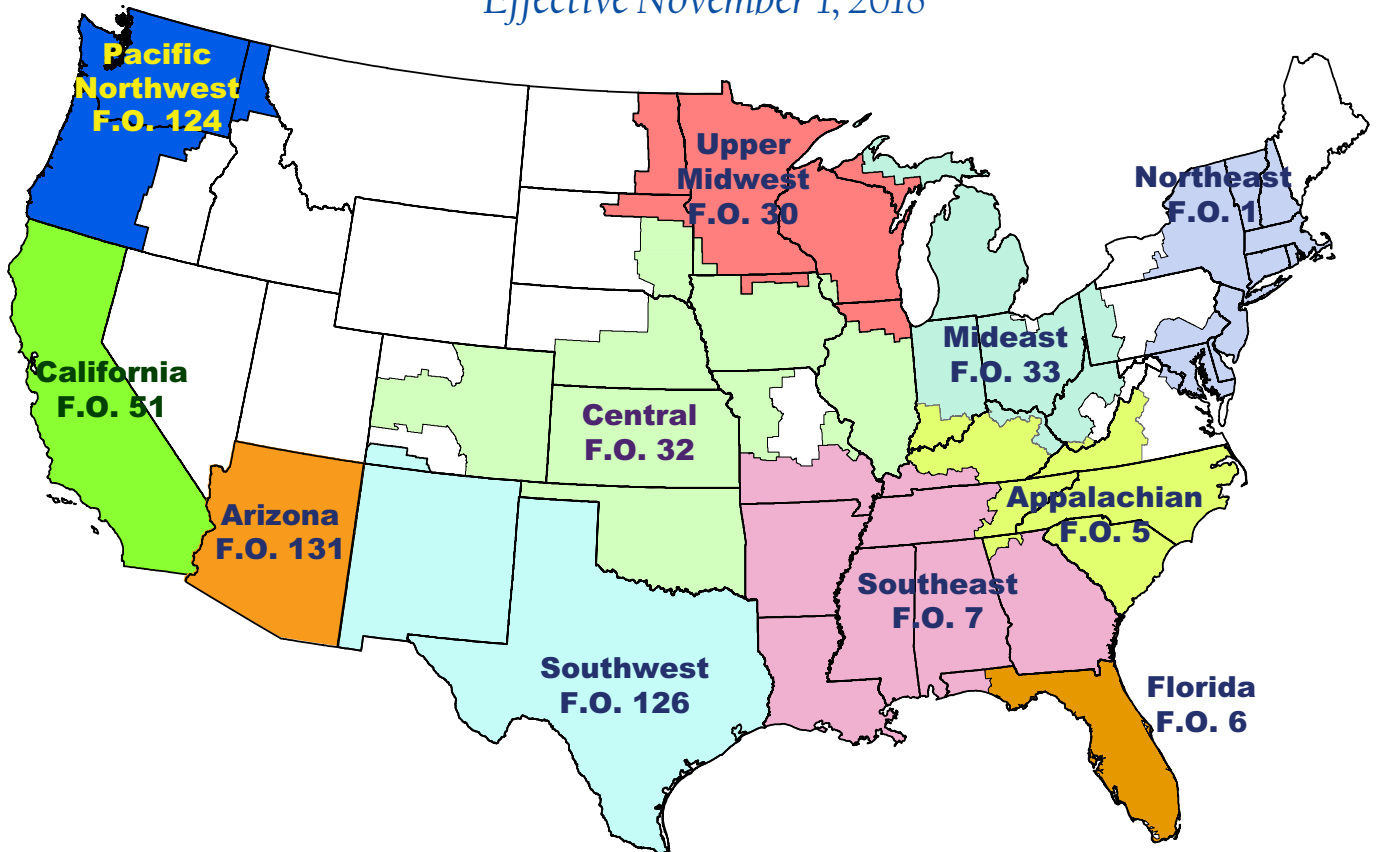
on the Monday morning of the training week, with the rest of the week reserved for individual sessions.

CME Dairy Prices Down Sharply in the Last Month

Dairy commodity prices on the Chicago Mercantile Exchange (CME) are all down sharply from May 25 to June 25, with the exception of Whey. The June prices are also below last year's levels. A graph depicting these changes is shown below.

The CME barrel cheddar cheese on June 25 was \$1.20 1/2 per pound, with 40-pound blocks at \$1.45. **The barrel price is at its lowest level since July 2009.**

The barrel price dropped 34¢ from a month earlier and was 16 1/4¢ below a

year ago, while the block price was down 16¢ from a month earlier and 7 1/2¢ below last year.

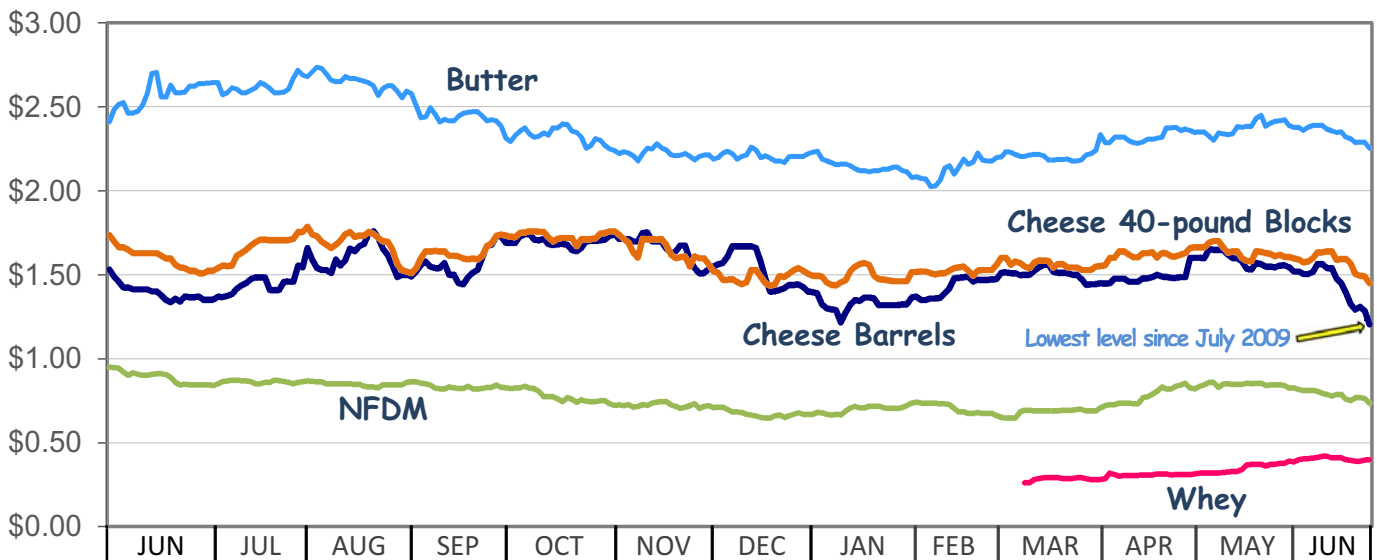
The CME butter price on June 25 was \$2.25 1/2 per pound, down 16¢ from last month and 36 3/4¢ below a year ago.

The price of nonfat dry milk (NFDM) on the CME on June 25 was \$0.73 3/4 per pound, down 10 1/2¢ from last month and 10 3/4¢ below a year ago. Since falling to the historically low level of less than \$0.65 in early March, the price rose more than 20¢ before beginning its latest decline in early May.

The May Federal order Class III price was \$15.18 per cwt., up 71¢ from April, the third consecutive monthly increase and its highest level since December 2017. The May price, however, is 40¢ below May 2017, and lower than any of the Class III prices in the last half of 2016 and each month of 2017.

The CME Class III Futures market doesn't currently have a very encouraging outlook. On June 25, the futures market had the price at \$15.21 for June, but falling to \$14.10 for July, and peaking for the year at \$15.75 for October and November.

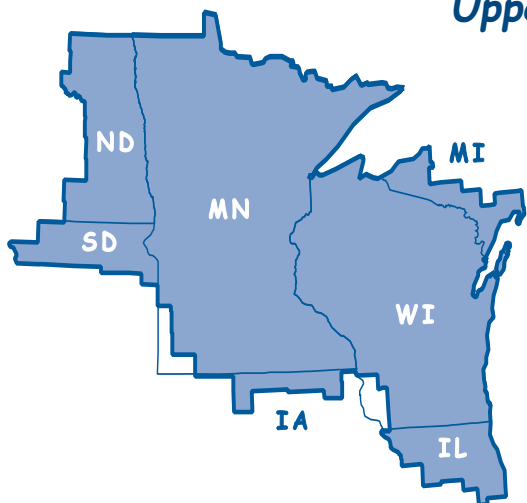
