Cheese and Butter Prices Fluctuate

Prices for cheddar cheese and butter on the Chicago Mercantile Exchange (CME) fluctuated during the period of mid-April to mid-May. Cheese prices ended the period little changed, while the butter price recovered somewhat after it fell to \$1.30 per pound on May 9.

The CME barrel cheddar cheese price on May 16 was \$1.46 per pound, unchanged from April 16. The 40-pound block price was \$1.50 per pound on May 16, up 1\(\frac{1}{2}\psi\$ from April 16. The barrel price was 18\(\frac{1}{2}\psi\$ below the year-earlier level, and the block price was down 13\(\psi\$.

The CME butter price on May 16 was \$1.35½ per pound, down 7¢ from April 16 and 64½¢ below a year-earlier.

The April Federal order Class III price was \$15.72 per cwt., unchanged from March, but \$1.15 below April 2011. The May CME Class III futures price on May 16 closed at \$15.26 per cwt., with June through December ranging from \$14.84 to \$15.90 per cwt. The futures prices for January to April 2013 averaged about \$15.60 per cwt.



Upper Midwest Order--Sources of Producer Milk

Producer Milk by State

During December 2011, 69% of producer milk was received from Wisconsin, with 22% from Minnesota (See Table 1 on Page 2). The remaining producer milk, about 10%, was primarily received from Illinois, Iowa, Michigan, and North and South Dakota. In addition, a small quantity of milk was pooled on the order from

each of the states of Idaho, Indiana, Kansas, Nebraska, New Mexico, Missouri and Utah.

Producer milk in December 2011 totaled 2.5 billion pounds, down 248 million pounds from the previous year. In December 2011, producer milk was received from Kansas, Nebraska, New Mexico and Utah, but not in December of 2010.

Pool Summary

- ➤ In April, producer milk totaled 2.89 billion pounds, down 48 million pounds from March, but 128 million pounds above April 2011.
- ➤ Class I utilization totaled 308 million pounds, down 1.7% from March on a daily basis. Class I usage accounted for 10.6% of producer milk.
- Class III utilization totaled 2.4 billion

- pounds and accounted for 84.0% of producer milk.
- ➤ The April Producer Price Differential (PPD) was \$0.20 per cwt.
- ➤ The Statistical Uniform Price was \$15.92 per cwt., down \$0.06 from March and \$1.59 below April 2011.
- ➤ Market statistics for April are shown on Pages 4 and 5.

The number of counties from which producer milk was received, the number of producers, and pounds of producer milk represented by each state in December 2011 are shown in Table 1 above. In addition, the percentage of producer milk represented by each state is shown for December of 2011, 2010, and 2009.

The map to the right depicts the states and counties from which producer milk was received in December 2011.

Producer Milk for 15 Top Counties

The 15 top counties from which producer milk was received in December 2011



are shown in Table 2 below, along with the number of producers and pounds of producer milk represented by each county. The rank, number of producers and pounds of producer milk for those same counties for December 2010 are also shown.

Wisconsin has 14 of the top 15 counties in December 2011, and Minnesota has the remaining one. The makeup of the top 15 counties in December 2011 was slightly different from a year earlier. The county ranked 14th in 2011, Waupaca, Wisconsin, was 18th in 2010, pushing Morrison County, Minnesota, ranked 15th in 2010, out of the top 15 in 2011.

There also was some shifting among the counties that remained in the top 15 in both years. Dane County, Wisconsin, ranked 5th in 2010, took the top spot in 2011, bumping Stearns County, Minnesota down one notch to the 2nd spot. All of the other counties shifted rank between the two years, with the exception of Kewaunee, Outagamie, Dodge, and Sheboygan Counties in Wisconsin. These counties were in their respective spots both years.

The top 15 counties supplied 39% of total producer milk on the order in December 2011, and accounted for 35% of the producers.




